### MEMORANDUM OF UNDERSTANDING

This Memorandum of Understanding (MoU) is made and entered into:

#### BETWEEN

Entudio Private Limited (hereinafter referred to as "Entudio"), a company involved in promoting the development of specialized technical skills and certification programs through training initiatives, having its registered office at 20A, Perumal West Car Street, Palayamkottai, Tirunelveli – 627002.

#### AND

Rohini College of Engineering and Technology, located at Palkulam, Kanyakumari, affiliated with Anna University, offering Engineering and Management Degree Programs.



mobilize students from the college collaborately with Entudio .

### **Training Support & Methodology**

- Training will be conducted on the premises of Rohini College of Engineering and Technology.
- Entudio will provide Subject Matter Experts and engineers for training students and faculty.
- Entudio will offer all necessary support for imparting training to the students.
- Training programs will be conducted based on mutually agreed terms.
- Certificates will be issued to students by Entudio from respective companies upon successful completion of certification exams.

### **Course Fee and Payment:**

- Entudio will prepare a list of students sponsored by Rohini College of Engineering and Technology each semester.
- Rohini College will sponsor students from Semester 1 to Semester 8, across all departments.
- The program fee is INR 5,500 per student per semester. It is mandatory for students to choose one program each semester.
- Rohini College acknowledges that the fees cover expenditure for infrastructure utilization, program content development, necessary hardware, course material, and lectures by certified/industrial experts.
- Payments will be made in favor of Entudio Private Limited.
- Programs offered to external students will be charged INR 5,500 for the academic year 2024-25. Rohini College will retain 15% per student as Infrastructure Charges. Program fees for external students will be revised annually based on feedback.

### **General Agreements**

- Both parties can issue press releases and make public announcements related to this Agreement without prior consent, ensuring it does not affect the objective, ethical values, and reputation of either organization.
- Entudio retains ownership of all equipment and infrastructure established at the COE until August 2030. During the MoU tenure, Rohini College of Engineering and Technology can use the COE facilities and Subject Matter Experts as needed.

### **Course Deliverables**

Entudio will adhere to its standard methodologies for conduct, student attendance, quality norms, feedback, assessments, evaluation, certification, and delivery of course content. Training will occur at Rohini College of Engineering and Technology. Course offerings will be reviewed and adjusted as necessary.



### **Validity**

The MoU is valid for 6 years, starting from the academic year 2024-25 and ending in 2030-31.

### **Arbitration Clause**

Disputes will be resolved jointly by the Managing Director of Entudio and the Director of Rohini College of Engineering and Technology. Unresolved disputes will be referred to arbitration governed by the Arbitration and Conciliation Act, 1996, conducted in Kanyakumari, with proceedings in English. Arbitration costs will be shared equally.

Regular meetings will be held between both parties to review program progress and address any difficulties in implementing the MoU.


